Domestic News

- · The prices of rice market remain flat to low.
- Bihar: Farmers are worried as paddy cultivation is lagging behind due to severe heat. The scorching heat is affecting paddy cultivation. Due to unfavourable weather, the paddy sowing of farmers is getting delayed. If farmers sow the seeds in a hurry, there is a risk of it getting spoiled. The seeds will get scorched after germination due to the sunlight during the day.(Source-LiveHindustan)
- Haryana: The target is to get direct sowing of paddy done in eight thousand acres in Sonipat. The Agriculture and Farmers Welfare Department has given the target of direct sowing of paddy in eight thousand acres to the subdivision Gohana. To achieve the target, the officials of the Agriculture Department are making the farmers aware. They are making them aware about the scheme. The department has also got direct sowing of paddy done in 900 acres so far. Assistant Technical Manager Krishna Khasa said that farmers adopt the traditional method of transplanting paddy. This consumes more water. Whereas direct sowing requires less irrigation. According to officials, direct sowing consumes 25 to 30 percent less water and the yield is also almost the same.(Source-Amarujala)




International News

Asian Rice weekly Updates

- Top exporter India's 5% broken parboiled variety was quoted at \$539-\$546 per ton this week, unchanged from the last week.
- Vietnam's 5% broken rice prices were offered at \$570-\$575 per metric ton on Thursday, down from a range of \$575-\$580 a week ago, traders said.
- Thailand's 5% broken rice was quoted at \$630 per ton, unchanged from last week. (Source-EconomicTimesIndia)
- Pakistan: Rice exports exceed expectations, reach record \$3.6bn. On the back of unprecedented increase in rice production to an all-time high of 9.9 million tons in FY24, exports of produce have jumped above expectation to US\$3.6 billion during the financial year. According to the latest data, with export of 5.59 million tons of rice, the commodity also topped the food group in external trade category. Pakistan's rice exports were pegged at \$3.5 billion in the current fiscal year in export advisory council meeting, held during the interim setup. If the momentum in export was sustained in the last month of present fiscal, rice export could reach the magic figure of four billion dollars against less than \$2.5 billion in the previous financial year. In the first nine months of fiscal year 2023-24, rice exports already broke all the previous records by earning all-time high of \$3 billion. Hike in rice exports have also partly been attributed to a ban imposed by India on rice exports. Overall, in July-March of FY24 period, the country earned \$2.939 billion in the first nine months of this fiscal year, compared to \$1.6 billion in the same period of the last fiscal year. 

Price Seasonality









Precipitation outlook for next four weeks:






