#### **Domestic:**

- The Prices of Bajra Market remained in decreasing trend.
- **Kharif Bajra sowing area remains stable:** According to Department of Agriculture & Farmers Welfare, the area under Kharif Bajra remains stable at 7001 thousand hectares same as sowed during the same period last year.
- India Bajra's arrivals during the current marketing year (Oct.-Sep.) were up by 24%, reported at 202.6 '000. tonne, compared to 154.2 '000 tonne reported for the same period last year.
- Farmers in Rajasthan are increasingly frustrated by the government's failure to purchase bajra at the declared Minimum Support Price (MSP) of ₹2,625 per quintal. Instead, they are selling their produce for only ₹2,200 to ₹2,400, leading to losses of over ₹300 per quintal. This situation highlights a systemic failure in agricultural policy, as

farmers have reported collective losses exceeding ₹1.50 crore, worsened by crop damage from excessive rainfall. The unfulfilled promise of a fair price, which should be closer to ₹2,904 based on prior commitments, further jeopardizes their livelihoods. With Rajasthan contributing nearly half of India's bajra production, the lack of effective support from the government threatens food security and rural welfare, necessitating urgent action to address farmers' grievances and restore trust in the agricultural system. • The Gurugram district administration has procured 17,877.2 metric tonne of bajra millet from 7,293 farmers at a minimum support price (MSP) of ₹2,625 per quintal. The procurement was made at mandis in Sohna (2,974.5 MT), Pataudi (11,955 MT), and Farrukhnagar (2,947.7 MT). Essential services, including help desks and safety measures, have been established to assist farmers, with payments made within 48 hours. Additionally, 6,252 metric tonne of millet have already been lifted from the mandis, and commission agents are also purchasing millet. (link)

#### International

• The International Rice Research Institute's recent push for direct-seeded rice (DSR) technology in northern Bangladesh represents a crucial advancement for food security in a region facing significant agricultural challenges. With rice as the staple food, the sector employs over 60% of the population. However, groundwater depletion, exacerbated by climate change and natural disasters, has left farmers struggling with water scarcity—especially in the Rangpur division. (Source-cgiar)
